

# Steps to Submission

when Newrez is underwriting your file

#### **Registration and File Submission**

- Register your loan with Newrez at newrezcorrespondent.com
- Submit loan to DU or LPA using Newrez Sponsorship.
  - Obtain documentation according to Findings or Feedback.
  - o Release or Assign findings to Newrez.
- O Upload your complete Credit Package to Newrez.
  - Complete the Underwriting Sub Checklist including contact information and include with the file upload.
  - Completion of the Underwriting Sub Checklist ensures loan level communication from Newrez.
  - o Confirm all AUS required docs are included with the submission.
- Select Image Central and then Import Images to begin uploading the initial Credit Package:
  - Select the loan file you wish to upload documents for and then select the initial Doc Type Credit File as shown in this example below



Select "Yes" in the Lender/Investor to UW box, input the required email address and then browse and find the file to upload and click upload new File. Example below:




### Loan Setup – Loan Setup Suspense Conditions & Status

- After submission and upload of the credit file, it will be reviewed by the Loan Setup Up team to confirm submission package is complete and includes everything from the UW submission checklist.
- Once the initial loan set up review is complete the Client UW Contact that was input at initial upload will be notified via email with status updates:
  - If the credit package is complete, you will receive email notification that the file has been moved into the UW queue.
  - If the credit package is not complete you will receive email notification the file was suspended in Loan set up and what else is needed.
- Loan Setup Suspense conditions will be added to the Loan Status section for that borrower. Loan Setup Suspense items are found under Loan Status and then the Suspense tab for that borrower. Ex below:



If file is suspended in Loan Set Up, upload all Set Up conditions in Image Central by selecting **Loan Setup Conditions** as your Doc Type and then select Lender/Investor to UW – **YES** – as seen below:



- If complete at initial submission, or when Set Up items have been cleared, the file will move to the underwriting department.
- Check the posted Turn Times for Loan Setup Conditions, Underwriting Reviews and Underwriting conditions. The day posted is the day that is being reviewed. See Turn Times job aid for further detail.
- o Check the status of the file on our website.
  - To determine loan status details under Pipeline Manager use either Loan Status or the UW Status Report. Both will provide items needed to be cleared.



## **Underwriting Decision**

- After receiving status update email the file has been moved to underwriting you may follow the turn times from the website to know when to expect the U/W decision. Turn times for U/W will not start until the file has been moved into the U/W queue.
- The Underwriting Decision will be emailed but can also be found on the Loan
   Status page for that borrower and then the U/W tab:



- Underwriting Decision may be:
  - Approved Prior to Close (PTC): loan has been approved subject to conditions that require U/W review before the loan can close.
  - Approved Clear to Close: all PTC conditions have been cleared by the U/W.
  - Suspended: The loan contains insufficient information to render a
    decision. A suspend notification may also be used for loans that are
    recommended for denial. These will be identified with an A001 condition
    on the suspend notification. To comply with Reg B, all suspended loans
    must be resolved within 30 days of the credit file receive date or the loan
    will be denied.
- From the Underwriting Decision Conditions under Suspense or the "Underwriter to Review" section should be uploaded through Image Central.
- From Image Central select Trailing and Suspense Documents as your Doc
   Type and select Lender/Investor to Underwrite "Yes":



o The underwriter will review and update the Underwriting Decision.

#### **Clear to Close and Submission for Purchase**

- When all "Underwriter to Clear" conditions have been satisfied, a Clear to Close will be issued.
- Loan is required to be locked prior to Clear to Close.
- The Closing package cannot be uploaded to Image Central until the loan has been issued a Clear to Close.
- After receiving the clear to close you may close the loan and submit to Newrez for purchase.

**REMINDER:** ECOA clock begins as soon as we receive the initial upload of the file – it is very important the file is complete! **Don't jeopardize your rate lock!** 

# **Efficiency Tips for a Faster Clear to Close**

- 1. Complete the UW Submission Checklist in its entirety including the contact information section
- 2. Finalize DU or LPA to Newrez
- 3. Submit all documentation according to the AUS
- 4. Include UCDP appraisal summaries with submission of appraisal
- 5. Submit all conditions together
- 6. Explain any unusual circumstance
- 7. Document income calculations
- 8. Document gift transfers
- 9. Refer to the <u>FHA Non-Delegated</u> Job Aid for direction on FHA transactions
- 10. Refer to the <u>VA Non-Delegated</u> Job Aid for direction on VA transactions
- 11. Review Loan Approval for:
  - a. Document expiration dates
  - b. Max qualifying rates
  - c. Max cash to close
